Submission

Proposals for panels and papers must be **submitted latest by February 2, 2015** via email to the Conference Chair, **Bindu Vyas, Ph.D.** binduvyas@kings.edu

Please submit one of the following:

- A completed paper.
- An abstract (between 100 and 600 words).
- A proposal (1-2 page summary) for a workshop, special session, poster session or panel discussion.

All submissions should follow this format and be complete. An abstract is to be in Times New Roman, 12 pt., justified. Abstracts will be printed in the publication exactly as presented here. Submissions must be sent electronically in Microsoft Word.

1. Name of the presenter[s]
2. In case of student presenter Name of Faculty Advisor
3. Institution[s] Name
4. Email address
5. Telephone
6. Type of presentation-[i.e. poster-viewing only, oral, exhibit, performance, panel]
7. Special requests-[i.e. technology including Internet access, PowerPoint, video, etc...]
8. Title of Research
9. Abstract-not to exceed 200 word
10. In the case of a panel discussion, the educational aims of the panel should also be stated.

Conference Proceedings

All papers will be subjected to a peer-review process and accepted papers will be published in the conference proceedings.
