2011: A Year in Review

In 2011, The Institute for Public Policy & Economic Development completed several large projects and conducted three major events.

The Institute organized and hosted the Fourth Annual Faculty Research Symposium in April. At this event, 30 faculty members from nine participating colleges and universities presented their research to their peers and the community. The Institute also held the Sixth Annual Indicators Report and Regional Forum in May. In attendance were members representing business, academia, local and state elected officials, and non-profit leaders. Finally, The Institute’s housing task force presented a housing symposium to the residential real estate and builder community.

The Annual Indicators Report was released as a part of The Institute’s community based research program. The Institute also produced five policy statements on major issues impacting NEPA, presented and distributed through The Institute’s task force network.

The bulk of the work in 2011 was proprietary research for a number of clients. Client based research accomplishments included:

- An Assessment of The Lackawanna Arts & Culture Plan
- Organizational and Fiscal Assessment and Policy Review for the City of Nanticoke
- Completion of a Statewide Housing Study on behalf of the Appalachian Regional Commission
- A Market & Feasibility Study for The Jewish Community Center
- Policy briefs, primers, and issue papers on Marcellus Shale for the Institute for Energy and Environmental Research.

In 2011, the Institute presented research to the Governor’s Commission on Marcellus Shale, the Pennsylvania Planning Association and the Housing Alliance of Pennsylvania. The Institute was also asked to be a part of the prestigious William Penn Foundation’s Strategic Planning Process. The Institute held “Bridging the Path to College” event for local K-12 educators in conjunction with Regional Education Laboratory. This event was held as part of the Education & Workforce Development Task Force’s effort to connect Pre-K to 20+ educators.

The Institute was selected to participate as part of the Scranton Times Annual Economic Forum – Outlook 2011 and was contacted over 75 times by local and national media in 2011.

The Institute looks forward to a busy and productive year in 2012 and remains committed to research and analysis leading to economic development in Northeastern and Central Pennsylvania.

Impact of Marcellus Shale on Housing

This fall the Institute completed a study for the Appalachian Regional Commission on the effects of natural gas exploration on housing in shale rich counties in Pennsylvania. The purpose of the study was to examine if Marcellus Shale exploration was impacting the availability of housing. The study also looked at issues and policies in our shale rich states.

Twelve counties in the region were selected based on Marcellus shale location and economic status. The Institute gathered a variety of demographic and economic data from those counties through census and other public records. The Institute also conducted a number of interviews with realtors, planning officials, public officials, and other stakeholders. This data was analyzed and a number of trends emerged.

The Institute's findings include:

- There is a shortage of housing supply with very little building in progress. This problem existed before Marcellus Shale development. However, the increase in population is bringing the issue to a head.
- Low-income residents have, in some cases, been forced out by rising rental costs.
- Several of the counties studied have not dealt with population/industry growth in 60 years.
- Most counties have no land use plans or zoning codes.
- Counties in the early phases will benefit from planning, studying best practices, and lessons learned from more mature Marcellus Shale counties.
